APCO International Telecommunicator of the Year!!!

In 2010, Executive Committee members, committee chairpersons and those running for office participated in a strategic positioning exercise designed to identify trends, scenarios, and actions that the chapter will encounter in the next 1-6 years. This exercise resulted in an action plan for Washington APCO-NENA designed to guide our chapter plans for the future. A survey was conducted (electronically & at the conference) asking members about what is important to them related to the chapter. Based on the information from the survey, the chapter moved forward with the development of a mentoring committee and increased opportunities for training and networking. The current Executive Committee members and those running for office participated in an update workshop in May in order to gauge progress and continue the planning for the chapter.

Mentoring

The Mentoring Committee is committed to providing support for APCO members who will one day take over the leadership roles within the organization and the industry as a whole, through continuous training, individual contact with other experienced members, and other vital networking opportunities. It is our focus to help members understand their role in managing their own professional development, to encourage career development and a continuation of the objectives and ideals of the Chapter.

Legislative Update

Diversion of 911 dollars from the State Budget — WA APCO-NENA members were directly involved in communicating with legislators about the importance of keeping 911 money where it belongs to modernize the State E9-1-1 system.

Pre Paid Wireless Excise Taxes—Unexpected bill introduced this year by wireless carriers. WA APCO-NENA was asked to support this bill. The bill did not move forward this year and Department of Revenue will implement the tax ruling from the Supreme Court.

911 Harassment Bill— On hold until the 2012 legislative session.

Retirement Age for Telecommunicators—One of the legislative priorities of the chapter over this year was working on legislation to recognize Washington State 911 Telecommunicators/Dispatchers as Public Safety Employees and with that recognition, to lower the retirement age to match that retirement classification. This project will require teamwork from the Unions, Guilds, and members across the state. Focus over the past year is how to generate funds to support this legislative issue and to retain a lobbyist. A donation button has been set up on the chapter website, advertising has been added to the site, and pass the hat opportunities have begun.

As you all know it has been a very event filled year, with our initial legislative agenda (9 -1-1 Harassment Legislation and Retirement Age) being put on the back burner with the Governor's proposed raid on the State 9-1-1 fund to support her budget. With this announcement our resources and attention were diverted to the proposed raid. A secondary issue, the State Supreme Court decision on Pre-paid wireless was also unplanned but necessary for our full engagement and attention to ensure 9-1-1 funding was not jeopardized in any solutions presented.

As part of this year's effort a second annual Washington APCO NENA Legislative Day was held on March 15th! We had several 9-1-1 coordinators and other APCO NENA members who travelled from all over the state to participate and help take the message to the legislators, to leave the State 9-1-1 Fund intact. Several members used this as an opportunity to learn how to make contact with your legislators, and how to share the message. We encourage each of you who have an interest in future years legislation to do the same. Do not worry if you are not a professional lobbyist, your legislators want to hear from you and what your issue means to you and your community. There is no one better to deliver that message than you. So please join us next year, we still have plenty of work to do and new issues to address.

If you can't attend in person, your email messages, phone calls, and letters from your boards are effective tools to provide a message and to let your legislator know these issues are important to you.

Please know that your efforts made a difference this year! It is because you got involved and communicated that the legislators heard your message and the State 9-1-1 Fund remained intact when so many other direct funds did not. Thank you all for a great team effort!

Chapter Services Report

Members of the Chapter Services Committee visited 3 agencies during the past year: CENCOM in Bremerton, Cowlitz County in Kelso, and Wahkiakum County 911 in Cathlamet. Information about these agencies was included in the chapter newsletters. Our membership has enjoyed these "virtual visits" to other communications centers around the state.

Two chapter meetings and training opportunities were held during this year in conjunction with Area Coordinator meetings/training.
