988 Experience -

988 went live in July 2022. No one reported experiences good or bad as they relate to 988 and its introduction.

Transform 911; Lora Ueland -

Effort out of University of Chicago Health Lab that is analyzing 911, staffing, workflow, sustainability, mental exposure, etc. Lora discussed how she was educated that this effort to analyze the 911 industry and related it to how she knows it has the potential to transform an industry that is essential, noble and honorable. The University is sending out a survey to the APCO membership with questions about the daily dealings, impacts, etc. It important to participate. Dr. Nuestedter is spear heading this study and utilizing research provide by Valley Com and Lora. The team conducting the research is looking to elevate and recognize 911 dispatchers to the professional level that they function.

Seven recommendations have come to light in an effort to transform 911:

- Recognize 911 telecommunicators as first responders
- If you are not sending police, give telecommunicators another resource for response

Transform911.org

Transforming the perception that is out in the world about 911 Telecommunicators. Read the report, there is an executive summary for you to review. Next steps are to implement some of the recommendations where they fit for each PSAP. If we can get some of these transformations implemented, we will be a better and better-rounded industry. Be willing to listen to different opinions.

NENA showed some support, however there has not been an official endorsement. The recommendations align with what NENA and APCO state as their mission and values.

Committee Updates

• Administrative Committee – Lora Ueland – All things administrative around WAN. Taking some of the varying roles, chapter finance audit, bylaws, etc. The Sunshine Fund was born out of the loss of Mollie Elliott. We decided to write a policy that mimicked what APCO Intl does

however to adapt to the circumstances that are varying for all the different situations. The sunshine fund will review each request. All dependent on how much funds we have. You can donate directly, there may be fund raisers, etc. There will then be a decision as to what we will do for each request. Policy will be crafted for your review.

Katy spoke to the basket auction. Every year at conference, we ask every PSAP to bring a basket that will then be auctioned off. That money goes directly to the Sunshine Fund. Molly ran the basket auction.

Chapter T-shirt that you can find order link information on the WAN website. The artwork was done by one of WAN's members. We currently have raised \$560.00. This campaign will go for two more days. The cost of the t-shirt is \$30.00 plus tax and shipping. Katy will open a second t-shirt campaign in the fall prior to Fall Conference.

- APCO Awards Committee Kris DeVore –reviewed the overview of the banquet and determining attendance and photos for the presentation.
- Engagement Committee Mary Sue and Karen Crawford. Compassionate care celebrating member successes, accomplishments, etc. Recognition is key.

- Events Committee Richard Kirton plans, coordinates, and manages chapter events; both in-person and virtually. This committee also plans and coordinates the banquet.
- TERT Committee chaired by Richard Long Manages Washington State TERT program, research, and document and provide tools to enhance TERT. This includes developing training, policies, and what is involved with TERT related deployments.
- Professional Development– Tina Meier solicit, review, select and coordinate program topics and content for educational opportunities. Call for papers has a due date of August 15th. Tina has solicited vendor response for tracks in the fall.
- Marketing Committee Brenda Cantu informs membership of chapter activities, initiatives, and opportunities to encourage chapter engagement.  - Main focus for this Legislative session is retirement options for telecommunicators.
 Labor unions are interested in this. Currently doing research and asking questions about retirement, what the average salary, life-cycle, etc. of telecommunicators is.
 - Scott Sigmon our lobbyist, will be providing information around what legislation we need to be paying attention to.
